We, the undersigned, Electors of the City of Cincinnati, Ohio, petition your honorable body to forthwith provide by ordinance, for submission to the electors of the City of Cincinnati, the following proposed Amendment to the Charter of the City.

AMENDMENT

TITLE: AN AMENDMENT TO THE CHARTER OF THE CITY OF CINCINNATI TO PREVENT THE EXPENDITURE OF MONIES BY THE CITY FOR RIGHT-OF-WAY ACQUISITION OR CONSTRUCTION OF IMPROVEMENTS FOR PASSENGER RAIL TRANSPORTATION (e.g., a trolley or streetcar) WITHOUT FIRST SUBMITTING THE SAME TO A VOTE OF THE ELECTORATE AND RECEIVING A MAJORITY AFFIRMATIVE VOTE FOR THE SAME.

TEXT: Be it resolved by the people of the City of Cincinnati that a new Article XVI of the Charter is hereby added as follows:

The City, and its various Boards and Commissions, may not spend any monies for rightof-way acquisition or construction of improvements for passenger rail transportation (e.g., a trolley or streetcar) within the city limits without first submitting the question of approval of such expenditure to a vote of the electorate of the City and receiving a majority affirmative vote for the same.
